Terms of Service — Rewrap Rewards Membership Program

TERMS OF SERVICE — REWRAP REWARDS MEMBERSHIP PROGRAM

1. PROGRAM OVERVIEW

Rewrap Rewards is a membership-based vehicle wrap program offered by Blueline Signs. All memberships operate on a minimum 12-month contract that auto-renews annually unless canceled according to the terms outlined herein. Members receive cumulative benefits, discounts, wrap services, print offerings, and long-term rewrap benefits based on their selected tier: Blueline Basic (Tier 1), Blueline Pro (Tier 2), or Blueline Elite (Tier 3).

2. MEMBERSHIP DEPOSIT & 30-DAY GUARANTEE

A refundable \$1,500 deposit is required at the time of enrollment for all membership tiers. The deposit is fully refundable for 30 calendar days. After day 31, the deposit becomes non-refundable, and the associated cancellation fee applies. Blueline Signs may hold or apply the deposit to unpaid balances, damage charges, or any outstanding invoices associated with the member's account.

3. MEMBERSHIP TIERS & BENEFITS

Membership benefits stack upward. Each tier includes all benefits provided by the tiers below it.

PRINT PACKAGE ITEMS (Tier 2 & Tier 3 Eligible)

Members may select from the following printed items:

- 250 Business Cards
- 100 Double-Sided Flyers (5.5" × 8.5")
- 100 Postcards (4" × 6")
- One (1) 3' × 6' Single-Sided Banner

Blueline Basic — Tier 1 (\$199/month)

Includes:

- 50% coverage wrap installation
- Annual wrap checkup
- Minor repair patches
- 10% off print shop services
- Discounts on cleaning products
- One 6-month checkup plus annual inspection

4-Year Benefit: Free wrap removal and free full rewrap at year 4 (member must remain active continuously).

Blueline Pro — Tier 2 (\$299/month)

Includes all Tier 1 benefits, plus:

- Full wrap installation upfront
- 2 Print Package Items per year
- 2 design hours per month (\$200 value)
- Priority scheduling
- 15% off additional wraps
- Free annual vinyl cleaning

4-Year Benefit: Free wrap removal + Free full rewrap + New design included + Material upgrades allowed (member pays retail difference only).

Blueline Elite — Tier 3 (\$499/month)

Includes all Tier 1 & Tier 2 benefits, plus:

- 5 design hours per month
- 4 Print Package Items per year
- Annual brand refresh
- Emergency wrap repair priority
- 20% off storefront signage

4■Year Benefit: Free wrap removal + Free full rewrap + Unlimited design revisions + Monthly rate locked permanently.

4. SCHEDULING POLICY

Design and wrap installation appointments typically schedule 3 months out. Members may reschedule up to 3 times per membership year. Excessive rescheduling may delay project timelines.

5. WRAP CARE REQUIREMENTS

Members must follow manufacturer■approved wrap care instructions. Damage caused by pressure washers, harsh chemicals, picking at edges, collision damage, road debris, or improper care is not covered.

Tampering with the wrap voids all repair, removal, and rewrap benefits.

6. WARRANTY LIMITATIONS

Blueline Signs is not responsible for failures caused by:

- Poor or failing paint
- Rust, oxidation, or bubbling
- Aftermarket coatings (ceramic, PlastiDip, etc.)
- Extreme temperatures or environmental exposure
- Physical impact or collision damage

7. AUTO■RENEWAL

All memberships automatically renew on month 13 at the same rate unless upgraded, downgraded, or canceled prior to renewal. No new deposit is required for renewal.

8. PAYMENT TERMS

Members must keep two valid credit/debit cards on file. Monthly dues are auto■charged. Late payments may result in late fees, benefit suspension, or application of the deposit toward the balance.

9. CANCELLATION TERMS

If canceled after day 31, the following fees apply:

- Tier 1 — \$1,500
- Tier 2 — \$2,500
- Tier 3 — \$2,500

10. LIABILITY LIMITATION

Blueline Signs is not liable for consequential, indirect, or incidental damages, including loss of business or earnings. Wrap performance depends on customer care and underlying vehicle condition.

11. GOVERNING LAW

This agreement is governed by the laws of the State of Oklahoma.

12. ACCEPTANCE

By signing the Membership Contract, the customer acknowledges, accepts, and agrees to comply with all terms of this Terms of Service agreement.

4. PAYMENT TERMS

A \$1,500 deposit is required upon enrollment. Monthly membership billing begins the month following deposit. Customer agrees to all recurring billing authorized in the Autopay Authorization Form.

5. FOUR■YEAR BENEFIT CYCLE

To qualify for free wrap removal and a free full rewrap, the customer must remain continuously enrolled and in good standing for a full 48 months.

6. MEMBER RESPONSIBILITIES

The member agrees to:

- Maintain valid credit/debit cards on file.
- Follow proper vinyl care guidelines.
- Avoid tampering with the wrap.
- Report issues immediately.
- Attend scheduled appointments or provide timely notice for rescheduling.

7. CANCELLATION POLICY

The customer understands that cancellation after day 31 results in:

- Tier 1 — \$1,500 cancellation fee
- Tier 2 — \$2,500 cancellation fee
- Tier 3 — \$2,500 cancellation fee
